Proposal for Legal Inspection of Babies' garments and clothing accessories

By the Bureau of Standards, Metrology and Inspection (BSMI), Ministry of Economic Affairs

Background:

In view of the fact that the processing of textile products usually have to adding various kinds of dyes, auxiliaries and finishing agents, and the agents may contain more or less harmful chemicals. When these tiny chemicals in the textiles accumulate to a certain amount, they will cause harmful effects to the skin, and even the human health. For protecting the health and safety of babies, the BSMI, after having consulted with interested parties, intends to regulate Babies' garments and clothing accessories.

CNS 15290, Labelling Criteria for Apparel And Garments

Inspection items:

Free formaldehyde, Prohibited azocolourants, Cadmium, Lead, Physical safety requirements, Organic Tin, and labeling.

Conformity assessment procedures:

Monitoring Inspection (including random inspection) and Monitoring Inspection of Products from Premises with Registered Management Systems.

Rate for Monitoring Inspection Inspection (including random inspection):

• 2.5% of CIF.

Rate for Monitoring Inspection of Products from Premises with Registered Management Systems:

• 0.2‰ of CIF.

Commodity Inspection Mark:

• The Roman letter "C" Mark labels printed by the BSMI or the Roman letter 'M' with a designated code, which was authorized by the BSMI, printed by the applicant.
