Proposal for Amendment to Legal Inspection of Automobile Tyres.

By the Bureau of Standards, Metrology and Inspection (BSMI), Ministry of Economic Affairs

Background:

The BSMI intends to adopt the revised standard CNS 1431:2015 of automobile tyres(hereinafter referred as "the commodities") as the inspection standard. The revised CNS 1431:2015 mainly remains the same as the current version, except adding requirements in Section 8 about the validity dates of use and installation of the commodities. In this proposal, the commodities will be required to comply with the revised CNS 1431, therefore, the commodities that are more than 6 years from the date of manufacture shall be deemed as non-compliant.
