6. Description of content: The NCC intends to regulate narrowband terminal equipment of mobile broadband business to respond to domestic IoT development and connect to the world. The draft technical specifications are based on 3GPP TS 36.521-1, CNS14958-1, CNS14959, CNS13438, CNS14336-1, Technical Specifications for Mobile Broadband Business Terminal Equipment and other international technical specifications. The scope applies to narrowband terminal equipment of mobile broadband business, such as LTE Machine Type Communications (LTE-M1) and narrowband IoT (NB-IoT).
