5. Title, number of pages and language(s) of the notified document: Draft Regulation on the Residue Limit for Impurity Heavy Metal Cadmium Contained in Cosmetics and Draft Regulation on the Management of Barium in Cosmetics (2 page(s), in Chinese)

Description of content: The Food and Drug Administration, Ministry of Health and Welfare, proposes the following regulations for cosmetics: <ol style="list-style-type: none">To lower the maximum level from 20 ppm to 5 ppm for impurity heavy metal Cadmium.To prohibit the use of Barium salts, with the exception of barium sulfate, barium sulphide, and of insoluble barium salts, lakes and pigments prepared from colouring agents. <p>衛生福利部食品藥物管理署提案訂定化粧品相關規定如下:</p> <ol style="list-style-type: none">不純物重金屬鎘之殘留量最大值從 20 ppm 降到 5 ppm。禁止使用鋇鹽在化妝品中，硫酸鋇、硫化鋇及色素的不溶性鋇鹽 (salts)、麗基 (lakes) 和顏料 (pigments) 除外。
