

Method of Drawing Voluntary Product Certification Mark

一、依自願性產品驗證實施辦法規定辦理。







- (二) 不予指定固定尺寸，但應以適當(方格子)比例大小標印於產品本體上。
There is no size restriction of the mark, but the mark shall be affixed to the body of the product in appropriate proportion (please see mark in grid).
- (三) 由申請人自行印製或鑄印方式之自願性產品驗證標誌，應使用不易變質之材質製作，內容清晰可辨且不易磨滅，並以永久固定方式標示。
The certification mark printed by the applicants shall be made by materials that are not easily altered, and the content shall be in a visible, legible and indelible from affixed permanently to each product.
- (四) 商品之其他標示不得與自願性產品驗證標誌混淆，或使消費者不易辨別商品檢驗標識。
Other markings that are likely to be confused with the certification mark shall not be used.
- (五) 自願性產品驗證標誌應標示於商品本體。但商品本體太小無法標示時，得依下列方式標示之：
The Voluntary Certification Mark shall be affixed to the body of the product. However, if the product is too small to accommodate the mark, it shall be affixed in accordance with the following methods:
1. 具有包裝者，於最小單位包裝標示之。
If the product is packaged, the mark shall be applied to the smallest package.
 2. 無包裝或其包裝不適宜標示者，以繫掛方式標示之。
If the product is not packaged or it is not appropriate to apply the mark to the packaging, the mark may be attached to the product by hang tags.
 3. 包裝標示或繫掛均不適宜者，置放於包裝內。
If applying the mark to the packaging or by hang tags is not appropriate, the mark shall be put inside the packaging.
 4. 以其他經標準檢驗局核准之方式標示之。
Other methods approved by the BSMI.
前項標識，應標示於商品明顯處，使消費者於購買或使用時能清楚識別。
The Voluntary Certification Mark should be affixed at a prominent location on the product in order for the consumers to identify it when they buy and/or use the product.
