## 雙方同意

- 於各自驗證系統宣傳文件中加入目前合作現況;
- 一方在合理的時限內,知會另一方其驗證程序或國家標準趨勢之任何重大改變;
- 與另一方保持聯繫,以確保本倘忘錄之運作順暢;
- 發展作業程序及宣傳資料;
- 以適當方式提供有關MEE[與BC[Q之資料。

上述措施實際執行之前雙方必須先就細節部份簽署協議。

## MEMORANDUM OF UNDERSTANDING

between

Bureau of Commodity Inspection and Quarantine (BCIQ)

and

Hungarian Institute for Testing and Certification of Electrical Equipment (MEEI)

The Bureau of Commodity Inspection and Quarantine, Ministry of Economic Affairs, Republic of China on Taiwan, hereinafter referred to as BCIQ and the Hungarian Institute for Testing and Certification of Electrical Equipment, hereinafter referred to as MEEI will conclude a Memorandum of Understanding in pursuance of their desire to cooperate in defined areas.

BCIQ has been established as the national supreme authority in commodity inspection and also offers testing and certification services for commodities, including electrical products.

MEEI is the only independent authorized institution in Hungary for testing, inspection, certification and approval of electrical and electronic appliances, equipment, components and their manufactures.

With the aim to promote trade between the Republic of China on Taiwan and the Republic of Hungary, and to facilitate exporters in both countries to introduce their products i.e. electrical products into the market of the other country, both parties confirmed their decisiveness and willingness to enter into a full-scale cooperation on a reciprocal basis.

Each of the parties agrees

- to mention the present cooperation in the promotional documents of its certification system:
- to inform the other party, within a reasonable time, on any significant changes occurring in its own certification procedures and on trends of national standardization:
- to maintain contact with the other party to ensure the smooth application of this memorandum;
- to contribute to the development of operating procedures and promotional materials;
- to present in an appropriate way the information on MEEI and BCIQ.

Before the realization of any of the above actions an agreement on details should be made.
