- **6. Description of content:** For the purpose of facilitating trade and expediting customs clearance, draft amendments are proposed to the Commodity Inspection Act to consolidate the provisions to streamline the physical operations. The proposal includes deletion of 1 Article, revision of 19 Articles and addition of 5 Articles. A summary of the draft amendment is described below:
 - 1. To relax border control by shortening the process required for products to be placed on the market.
 - 2. To prohibit display of non-compliant commodities by distributors so as to reduce the possibility of such products to be placed on the market for circulation.
 - 3. To require disclosure of accurate testing results by manufacturers to reduce the cost of consumers spent in verifying the information presented in advertisements.

To require that manufacturers comply with new inspection standards when it is deemed necessary to fulfil the objectives of safety, health, environmental protection, improving the efficiency of resource utilization, or other public welfare purposes.
