- **Description of content:** Alcohol products are required to label lot numbers of production starting from 20 January 2007. The lot numbers refer to specific characters, numerals or symbols that indicate the "lot" of the product, by which the record of each lot of production can be traced for audit. A "lot" number of a product refers to a specific amount of products produced by a particular production line within a specific period of time. In the case that the label of an alcohol product bears the date of packing or expiration and such date can be used to deduce the date of packaging, the date of packing or expiration can be regarded as the lot number of production.
