- **6. Description of content:** The Labelling Criteria for Textiles was amended in August 2006 to add a requirement for the labelling of telephone numbers of manufacturers or importers so as to provide the consumers with the necessary information about the products. The labelling of this additional information is required to be labelled on the body of products in the form of sewing tags or hang-on tags or labelled on the inner or outer wrappers.

In addition, the labelling of country of origin shall be made in the form of sewing tags, together with other information such as fibre contents and care instructions, in a manner that the tags are placed in a conspicuous place and the labelled information is not worn-out or becomes indelible after washing. The country of origin and other information shall also be labelled on the outside package for packaged textiles.
