- **6.** Description of content:
  - Containers to be regulated:
    - 1. Plastic trays and boxes used in hypermarkets and supermarkets for packaging eggs, fresh foods, deli and bakery.
    - 2. Plastic disposable food containers used in hypermarkets and supermarkets.
    - 3. Tray, boxes and food containers containing PET, PS, PVC, PE or PP are considered plastic.
  - Content of the Regulation: hypermarkets and supermarkets shall reduce 25% yearly use of the regulated containers.
  - Hypermarkets and supermarkets may use the following approaches to achieving the targeted goal of reduction:
    - 1. Use no trays or boxes.
    - 2 Reduce the weights of regulated containers.
    - 3. Replace regulated containers with containers made of other materials, such as paper, plant fibres, and biodegradable materials.

- Calculation: Use Reduction Rate = "percentage of substitutes used" + "percentage of weight reduction of regulated containers"
- Obligations: hypermarkets and supermarkets shall submit reduction plans to the local Environmental Protection Bureau every year and implement such plans. Hypermarkets and supermarkets shall report the reduction rate achieved in the previous year to the local Environmental Protection Bureau.
- Penalties: Violators shall be imposed a fine at the amount from NTD 30,000 to 150,000

  Resource conservation and waste reduction
