- **Description of content:** Medium density fiberboard and particleboard have been widely used as a kind of building materials these days. The public is concerned about pollution of indoor air by formaldehyde emitted from adhesive bonded wood products and demands restriction on the use of formaldehyde glue in medium density fiberboard and particleboard products. Besides, for protecting the public safety, we also need to ensure the fire-retardant properties of those products. The BSMI, after having consulted with interested parties, intends to regulate the medium density fiberboard and particleboard products.
