As of 1 January 2009, all such products must be inspected by the Bureau of Standards, Metrology and Inspection (BSMI), and must conform to the requirements of "Standard of Prevention and Guarding Devices—Machinery and Tools" when marketed. The Standard for the aforementioned products are announced by the Council of Labour Affairs on 27 July 1992 and amended on 30 July 2004. The conformity assessment procedure for power press or shearing machinery and similar equipment is Registration of Product Certification (RPC) Scheme.
