- 5. Title, number of pages and language(s) of the notified document: Proposal of prohibiting the use of Di-n-octyl phthalate in cosmetic products (1 page in Chinese, English translation available)
- 6. **Description of content:** According to Paragraph 1, Article 23 of the Statute for Control of Cosmetic Hygiene, cosmetics or cosmetic colorants that are detrimental to human health shall be prohibited to be imported, manufactured, distributed or placed on the market. Due to the possibility of interfering with human endocrine system, "Di-n-octyl phthalate" has been classified as a possible substance of environmental hormones. Having recognized that Di-n-octyl phthalate is not a required material for manufacturing cosmetic products, the Department of Health intends to propose the prohibition of the use of Di-n-octyl phthalate in cosmetic products by taking the following measures:
  - 1. To add Di-n-octyl phthalate to the list of prohibited cosmetic ingredients;
  - 2. To prohibit the import and manufacturing of all cosmetics containing Di-n-octyl phthalate. Reformulation of medicated cosmetic products containing this ingredient shall be required.

- 7. Objective and rationale, including the nature of urgent problems where applicable: Consumer protection and to reduce public exposure to environmental hormones.
