- **5. Title, number of pages and language(s) of the notified document:** Requirements of Labelling and Inspection of Energy Consumption and Energy Efficiency Rating for Selfballasted Fluorescent Lamps
- 6. **Description of content:** The Bureau of Energy intends to propose an energy efficiency labelling scheme to regulate energy performance for self-ballasted fluorescent lamps. The proposed labelling scheme applies to both imported products and domestically manufactured products. In addition to the scheme, the proposed technical regulations also specify the labelling requirements, the conformity assessment procedures and post-market surveillance actions. Products that fail to conform to the requirements will be prohibited from being sold and placed on the domestic market.

Labelling for self-ballasted fluorescent lamps under the authorization of Energy Management Act will be divided into five grades, and should include the items below:

- 1. Product names:
- 2. Product model number;
- 3. Rated Power (W);
- 4. luminous efficacy (lm/W);
- 5. Energy efficiency rating;

- 6. The year and announcement number of the Announcement containing the Criteria for Energy Efficiency Rating of Self-ballasted Fluorescent Lamps used for this rating determination;
- 7. Registration number for this rating; and
- 8. Other text as designated by the central competent authority.
- 7. Objective and rationale, including the nature of urgent problems where applicable: To promote energy efficiency of the said products to achieve the national goals of energy conservation and environmental protection.
