6.	Description of content: The Bureau of Energy intends to propose an energy efficiency labelling scheme to regulate the energy performance for Gas Stoves. The proposed labelling scheme applies to both imported products and domestically manufactured products. In addition to the scheme, the proposed technical regulations also specify labelling requirements, the conformity assessment procedures and post-market surveillance actions. Products that fail to conform to the requirements will be prohibited from being sold and placed on the domestic market.
	This labelling for Gas Stoves, under the authorization of Energy Management Act, will be divided into five grades and should include the following items:
	1. Product names(Gas Stoves)
	2. Product model number(Fuel Type)
	3. Total gas consumption(kW)

- 4. Thermal efficiency value
- 5. Energy efficiency rating
- 6. The year and announcement number of the Announcement containing the Criteria for Energy Efficiency Rating of Gas Stoves used for this rating determination
- 7. Registration number for this rating
- 8. Other text as designated by the Central Competent Authority
- 7. **Objective and rationale, including the nature of urgent problems where applicable:** To promote energy efficiency of the said products to achieve the national goals of energy conservation and environmental protection.
