- 6. **Description of content:** The Valves for Liquefied Petroleum Gas Cylinder were announced to be subject to mandatory inspection on 15 November 1972. The Bureau of Standards, Metrology and Inspection (BSMI) will adopt the revised standard CNS 1324 'Valves for Liquefied Petroleum Gas Cylinder' (promulgated on 7 June 2010), harmonized with JIS B 8245: 2004, as new testing and inspecting standard, instead of the current CNS 1324 (promulgated on 12 September 2005), harmonized with JIS B 8245: 1994. The BSMI is proposing that, beginning from 1 March 2012, valves for Liquefied Petroleum Gas Cylinder covered in the inspection scope must comply with related CNS standards when imported or placed on the market.
