<b>6.</b>	<p><b>Description of content:</b> The Bureau of Energy intends to propose an energy efficiency labelling scheme to regulate the energy performance for Electric Pots. The proposed labelling scheme applies to both imported products and domestically manufactured products. In addition to the scheme, the proposed technical regulations also specify labelling requirements, the conformity assessment procedures and post-market surveillance actions. Products that fail to conform to the requirements will be prohibited from being sold and placed on the domestic market. This labelling for Electric Pots, under the authorization of Energy Management Act, will be divided into five grades and should include the following items:</p> <ol style="list-style-type: none"> <li>1. Product names(Electric Pots);</li> <li>2. Product model number;</li> <li>3. Rated water capacity(Litres);</li> <li>4. Normalized standing loss per 24 h value (kWh/24 h);</li> <li>5. Energy efficiency rating;</li> <li>6. Annual electricity consumption (kWh), which is calculated by the normalized standing loss per 24 h value (kWh/24 h) X 365 days/year;</li> <li>7. The year and announcement number of the Announcement containing the Criteria for Energy Efficiency Rating of Electric Pots used for this rating determination;</li> <li>8. Registration number for this rating;</li> <li>9. Other text as designated by the Central Competent Authority.</li> </ol>
