  - 1. Food retailers with company registration or business registration:
    - a) Bulk foods such as material other than beef or edible cattle offal must be labelled with product name and country of origin or letters with the same meaning;
    - b) Bulk foods such as material for beef or edible cattle offal must be labelled with product name, country of origin and country of origin of the beef or edible cattle offal or letters with the same meaning; if the contents include a single item of raw beef or edible cattle offal, it is permitted to label just one option i.e. either country of origin of the food or country of origin of the beef or edible cattle offal; in case of foods for baking (roasting) and dealing with ready-to-eat foods on-site, the food is only labelled with country of origin of the beef or edible cattle offal.
  - 2. Food retailers without company registration or business registration: Bulk foods such as material for beef or edible cattle offal must be labelled with country of origin of the beef or edible cattle offal or letters with the same meaning.

- 7. Objective and rationale, including the nature of urgent problems where applicable: Consumer protection. Under the premise of food safety, to provide consumers with clearly identified information, regulate the retailers need to label country of origin of the beef and cattle edible offal or letters with the same meaning. Some consumers, who wish to select the veterinary drug-free beef or cattle edible offal, could use the information in the food label to select items by their own choice.
