The inspection items include incombustibility etc. In consideration of the amendment of CNS and the integrity of inspection commodities, BSMI intends to regulate the safety and physical performance of the calcium silicate board (type c), fiber reinforced cement sidings, 0.8 and 1.0 regenerated fiber cement boards.
