- 6. **Description of content:** The safety for steel products is highly concerned in Taiwan, especially in terms of (pre-painted) hot-dip zinc-coated steel sheets and coils. In order to enhance the protection of consumers, the BSMI intends to regulate the inspection requirements for (pre-painted) hot-dip zinc-coated steel sheets and coils. The conformity assessment plan for all such products will be under the Registration of Product Certification (RPC) Scheme.
