- 5. Title, number of pages and language(s) of the notified document: Regulations Governing the Labeling of Flavoring Ingredients on Pre-packaged Food Products (2 pages in Chinese, English translation available)
- 6. **Description of content:** Based on Article 23 of the Act Governing Food Sanitation, the FDA proposed to regulate the labelling of pre-packaged food products. The notified measure applies to pre-packaged food containing flavouring agents. Flavouring agents are usually made from several dozens to hundreds of compounds. Considering that it is difficult to label each ingredient in the limited space of the food containers or external packages, the FDA proposed that the term "flavouring agents" be used if flavouring agents are added, and "natural flavouring agents" be used if the flavouring agents are natural.
