- 5. **Title**, **number of pages and language(s) of the notified document**: Amendments to Article 2, Article 6, and Article 7 of the "Vehicular Air Pollutant Emission Standards".
- **6. Description of content:** The Environmental Protection Administration proposes to amend the Vehicular Air Pollutant Emission Standards. The amendments are as follows:
 - 1. Amendment to the definition of "idle testing" (Article 2)
 "Idle testing" means measurement of the concentration of emitted pollutants from the exhaust pipe when a vehicle is running at idle;
 - 2. Amendments to motorcycle regulations with respect to emission standards, durability warranty, OBD requirement, and zero emissions requirement at idle for the next two stages. (Article 6):
 - WMTC Driving Cycle Testing Emissions Standards;
 - The emission limit values for CO/THC/NOx will be 1140/380/70 mg/km respectively for PI/PI hybrid motorcycles with Vmax<130 km/h after 1 January 2017;
 - b. The emission limit values for CO/THC/NOx will be 1140/170/90 mg/km respectively for PI/PI hybrid motorcycles with Vmax \geq 130 km/h after 1 January 2017;
 - c. The emission limit values for CO/THC/NMHC/NOx/PM (DI only) will be 1000/100/68/60/4.5 mg/km respectively for PI/PI hybrid motorcycles after 1 January 2021.

- Idle Testing Emissions Standards:

The idle emission limit values for CO/THC will be 2.0 %/1000 ppm respectively for both new motorcycles and in-use motorcycles after 1 January 2017.

- Durability Warranty:
 - a. The durability warranty will be 20,000 km/5 years for motorcycles with Vmax<130 km/h after 1 January 2017;
 - b. The durability warranty will be 35,000 km/5 years for motorcycles with $Vmax \ge 130$ km/h after 1 January 2017.
- All the motorcycles must be equipped with the On-Board Diagnostics (OBD) after 1 January 2017.
- Zero Emissions Requirement at Idle
 - a. The Companies with domestic sales volume of more than 10,000 motorcycles must have at least 20% engine families belonging to electrical motorcycles, hybrid motorcycles, or idle-stop motorcycles after 1 January 2017.
 - b. The Companies with domestic sales volume of more than 10,000 motorcycles must have at least 50% engine families belonging to electrical motorcycles, hybrid motorcycles, or idle-stop motorcycles after 1 January 2021.
- 3. Amendments to motorcycle regulations with respect to evaporative HC standards from fuel tank and fuel supply system for the next two stages (Article 7)
 - Evaporative HC Emission Standard for SHED Test
 - a. The evaporative HC emission limit values from fuel tank and fuel supply system of motorcycles will be 2,000 mg/test after 1 January 2017.
 - b. The evaporative HC emission limit values from fuel tank and fuel supply system of motorcycles will be 1,500 mg/test after 1 January 2021.
- 7. Objective and rationale, including the nature of urgent problems where applicable: To further improve air quality further and be in line with the emission standards of Euro 4/Euro 5 for motorcycles.
