6.	Description of content: The safety for walking sticks products is highly concerned in Taiwan, especially in terms of non-wood walking sticks. In order to enhance the protection of elderly or disabled consumers, the BSMI intends to regulate the inspection requirements for non-wood walking sticks. The conformity assessment plan for all such products will be under the Registration of Product Certification (RPC) Scheme.
