Title, number of pages and language(s) of the notified document: Announcement for Amendment to Legal Inspection of Toy Commodities (3 pages, in English) Description of content: The Bureau of Standards, Metrology and Inspection (BSMI) is 6. very concerned about the safety of toys, no matter where they might be manufactured. To protect consumer rights and interests, all toys, whether domestically produced or imported from abroad, must be in compliance with the inspection requirements before they are released from the production premises or the Customs. The main measure of CNS which was revised on 4 December 2012, increases the requirements 4797 with limitation of Formamide less than 2 ppm, total amount of DMP, DEP, DEHP, DBP, BBP, DINP, DIDP, and DNOP in Phthalates, less than 0.1%, and for toys, containing a liquid substance, the biological safety requirement with bacterial counts less than 3,000 CFU/g and without detected any Escherichia coli, Pseudomonas aeruginosa, Salmonella, and Staphylococcus aureus in Article 4. 7.
