 - 1) Add the definition of "PMR" to Article 2: "PMR": denotes the Power-to-Mass Ratio Index, means the ratio of rated maximum net power of a vehicle to its mass. It's defined as: (Rated maximum power, kW)/(test vehicle's mass, Ton)
 - 2) Amendments to motor vehicle noise control standards with regards to 5th and 6th control Periods (Article 3):
 - Table 1 for Motor Vehicle Noise Control Standard Values of 5th Period.
 - Table 2 for Motorcycle Noise Control Standard Values of 6th Period.
- 7. Objective and rationale, including the nature of urgent problems where applicable: In order to ensure the effective control of environmental noise quality for public environment protection, and to harmonize with the latest international environmental norms.
