ICS numbers may be provided in addition, where applicable): Existing chemical substances that are listed on the chemical inventory by the Environmental Protection Administration and new chemical substances which are not listed on the existing chemical inventory
- **5. Title, number of pages and language(s) of the notified document:** Regulation of New and Existing Chemical Substances Registration (Draft) (18 pages, in English)
- **6. Description of content:** The Toxic Chemical Substances Control Act (TCSCA) was amended and promulgated on December 11, 2013. This notified subordinate implementing law "Regulation of New and Existing Chemical Substances Registration (Draft)" is enacted pursuant to Article 7-1, Paragraph 6 of the TCSCA. In accordance with TCSCA, this regulation is aimed at achieving several objectives for sound chemical management, including applying standard registration, simplified registration, or small quantity registration for new chemical substances; Phase-in of designated registration for existing chemical substances; registration for chemicals used for special purposes or having special forms; and joint registration.

Also this draft regulation specifies respective thresholds and information requirements of all types of registration, review procedures, and conditions attached in granting permits, as well as validity period of permits, post registration extension, modifications with new evidence, revocation, cancellation and keeping of registration documents. Schemes and management concerning early inclusion of new chemical substances and polymers of low concern listed on the chemical substance inventory are proposed. Regarding business interests and the general public's right to know, rules on information dissemination and protection of confidential business information are also introduced.

 To strengthen management of toxic chemicals and to enhance the protection of the environment and human health; Protection of human health or safety; Protection of the environment.
