- **5. Title, number of pages and language(s) of the notified document:** Regulation of New Chemical Substances Registration (Draft) (9 pages in Chinese, English translation available)
- **6. Description of content:** The Occupational Safety and Health Act was amended and promulgated on 3 July 2013 and came into force on 3 July 2014 by the announcement of the central competent authority.

This notified subordinate implementing law "Regulation of New Chemical Substances Registration (Draft)" is enacted pursuant to Article 13 of Occupational Safety and Health Act.

In line with Occupational Safety and Health Act, this regulation is aimed at achieving several objectives for sound chemical management, including applying standard registration, simplified registration, or small quantity registration for new chemical substances, as well as joint registration.

Also this draft regulation provides legal definition and exemption, which also specifies respective thresholds and information requirements on a chemical safety assessment report of all types of registration, including validity period. Schemes and management concerning early inclusion of new chemical substances and polymers of low concern listed on the inventory of chemical substance are proposed. Regarding business interests and the general public and worker right to know, rules on information dissemination and confidentiality of chemical names are also introduced.

**7. Objective and rationale, including the nature of urgent problems where applicable:** To strengthen management of chemicals and to enhance the protection of worker's safety and health.
