Description of content: Cement products have been subject to mandatory inspection under the Commodity Inspection Act by the Bureau of Standards Metrology and Inspection (BSMI) since 1 January 1972. The current inspection standard CNS 15286 of blended hydraulic cement was promulgated on 19 December 2011. The BSMI will soon adopt the revised CNS 15286 Standard, which was promulgated on 30 July 2014. Besides, the BSMI will revise cement products' description of goods [see Products (HS/CCCN codes) covered and their applicable inspection standards].
