The current inspection standard CNS 4879 of motorcycle tyres was promulgated on 15 September 2011. The BSMI will adopt the revised CNS 4879 Standard, which was promulgated on 9 October 2014. Besides, the BSMI will revise motorcycle tyres' description of goods [see Products (HS/CCCN codes) covered and their applicable inspection standards].
