- 5. **Title, number of pages and language(s) of the notified document:** Public Notice under the Commodity Inspection Act (9 pages, in English; 7 pages, in Chinese)
- **6. Description of content:** The BSMI intends to refine the current management of plywood products so as to maintain consistency of the requirements. The proposed measures are summarized below:
 - 1. To use "plywood" as the product description for related products. The current product names include plywood, special plywood, structural plywood, plywood for concrete-form, and scaffolding plywood, which are already subject to regulatory inspection. The inspection scope would be annotated in parenthesis.
 - To apply the same inspection requirements, mainly labelling of place of origin and formaldehyde limit, to all plywood products, which involves the adoption of revised inspection standards for related products (CNS 1349:2014 for plywood, CNS 8058:2014 for special plywood, CNS 11671:2014 for structural plywood, CNS 8057:2012 for plywood for concrete-form and CNS 11670:2014 for scaffolding plywood).
 - 3. To extend the current inspection scope to cover "plywood for pallet" of which the inspection standard is CNS 15583:2012 for plywood for pallet.
- 7. Objective and rationale, including the nature of urgent problems where applicable: Protection of consumers' safety
