Description of content: Laminated veneer lumber has been subject to mandatory inspection under the Commodity Inspection Act by the Bureau of Standards Metrology and Inspection (BSMI) since 1 January 2007. The inspection standards CNS 11818 for laminated veneer lumber and CNS 14646 for structural laminated veneer lumber were revised and published on 18 December 2014 and 20 August 2015 respectively. The BSMI will soon adopt the revised standards CNS 11818 and CNS 14646 as inspection standards, in order to enhance consumer protection. Besides, the BSMI will revise the Description of Goods of laminated veneer lumber [see Products (HS/CCCN codes) covered and applicable inspection standards]
