6.	Description of content: Wooden floors have been subject to mandatory inspection under the Commodity Inspection Act by the Bureau of Standards Metrology and Inspection (BSMI) since 1 January 2009. The inspection standards, CNS 2871 for block flooring and mosaic parquet, CNS 11341 for strip flooring and CNS 11342 for composite wood flooring, were revised and published on 9 October 2014. The BSMI intends to adopt the revised standards CNS 2871, CNS 11341 and CNS 11342 as inspection standards, in order to enhance consumer protection.
7.	Objective and rationale, including the nature of urgent problems where applicable: Protection of consumers' safety
8.	Relevant documents: The Commodity Inspection Act, CNS 2871, CNS 11341, CNS 11342
