- **Title, number of pages and language(s) of the notified document:** Requirements on Minimum Energy Performance Standard and Energy Efficiency Rating Labelling and Inspection of Household Refrigerators and Refrigerator-Freezers (4 pages, in English; 4 pages, in Chinese)
- **6. Description of content:** With a view to enhancing the efficiency of energy use, the Bureau of Energy intends to modify the energy efficiency rating labelling requirements, but the minimum energy performance standards will keep as the same as carried out in 2011, based on related national standards. A transition period about one year will be allowed for manufacturers to adapt to the proposed requirements.
- **7. Objective and rationale, including the nature of urgent problems where applicable:** To promote high energy efficiency electric appliances to achieve the national goal of energy conservation and environmental protection
- **8. Relevant documents:** Energy Management Act; CNS 2062 (Household Refrigerators and Refrigerator-Freezers)
- **9. Proposed date of adoption:** To be determined
