Description of content: To reduce the difficulties in identifying printers or photo-copying machines in terms of multifunction printing equipment, the Bureau of Standards, Metrology and Inspection (BSMI) proposes to revise the current conformity assessment procedures of photo-copying machines (i.e., Module II+IV or II+V, or II+VII under RPC scheme) to be in line with printers (i.e., Module II+III under RPC scheme), also, to combine printers and photo-copying machines into one inspection item printing or copying machines. In addition, for purpose of clarity and ensuring safety of related multifunction printing equipment, printing or copying machines with facsimile or scanning function, and for printing labels, barcodes, receipts, numbers, photographs, and bankbooks, will be included in this proposal. 標準檢驗局提案修正影像複印機的符合性評鑑程序(RPC 的模式 2+4 或模式 2+5 或模式 2+7)，與印表機(RPC 的模式 2+3)相同，以及將印表機和影像複印機合併成一項檢查項目。 此外，為確保相關多功能事務機的安全，包括具有傳真或掃描功能的印表機或複印機，及用於列印的標籤、條碼、收據、數字、照片和存摺之印表機。
