Description of content: The Bureau of Standards, Metrology and Inspection (BSMI) intends to update the inspection standards of toys by adopting the revised version of CNS 4797-3, which is cited in CNS 4797 and published on 15 July 2015. The revisions mainly involve new requirements for "acoustics," "toy scooters" and "magnets".
