6.	<b>Description of content:</b> In order to enhance the protection of consumers, the Bureau of Standards, Metrology and Inspection (BSMI) proposes to regulate chargers and secondary lithium batteries for electrical bicycles and electrical assisted bicycles.  For chargers, the inspection standards are CNS 15425-1 for safety, CNS 13438 for EMC, and section 5 of CNS 15663 for marking of presence conditions of 6 hazardous substances. For secondary lithium batteries, the inspection standards are CNS 15424-1, 15424-2 and 15387.  The conformity assessment procedure for all such products will be the Registration of Product Certification (RPC) Scheme (Module II+ III).  為了加強對消費者的保護，標準檢驗局(BSMI)提案規範電動自行車和電動輔助自行車的充電器和二次鋰電池。  充電器檢驗標準為安全性標準 CNS 15425-1、EMC 標準 CNS 13438 和規定標示 6 種有害物質含有情況的 CNS 15663 的第 5 節。二次鋰電池檢驗標準為 CNS 15424-1、15424-2 和 15387。
