6.	Description of content: The BSMI proposes to delete CNS 3706 "Tires of Cross-country Pattern and Mud and Snow Pattern" from the current applicable inspection standards of automobile tyres. The standard was withdrawn on 12 June 2017 and replaced by CNS 1431:2015, which is the other applicable standard for performing inspection of the product. 標準檢驗局提案將 CNS 3706「越野及泥雪地用特殊花紋外胎」標準從現行汽車用輪胎適用之檢驗標準刪除。該標準業於 2017 年 6 月 12 日廢除，並由 CNS 1431:2015 所取代，該標準為其他適用標準，用作檢驗汽車用輪胎。
