5.	Title, number of pages and language(s) of the notified document: Requirements on Minimum Energy Performance Standard and Energy Efficiency Rating Labelling and Inspection of Air Compressors (Draft) (6 page(s), in English; 6 page(s), in Chinese)

Description of content: Aiming to enhance the efficiency of energy utilization, the Bureau of Energy intends to expand the regulative scope of energy consumption standard and energy efficiency grade labelling scheme to include air compressors so as to reduce electricity loss. The proposed scheme applies to both imported products and domestically manufactured products. In addition to the scheme, the proposed technical regulations also specify labelling and inspection requirements, the conformity assessment procedures and post-market supervision. Products that fail to conform to the requirements will be prohibited from being sold and placed on the domestic market. 為提升能源使用效率，能源局擴大容許能源耗用基準規定範圍與能源效率分級標示計畫，納入空氣壓縮機以減少電力損失。本提案適用於進口產品和國內產製產品。此外，提案技術性法規敘明標示和檢驗規定、符合性評鑑程序和後市場監督。產品不符合規定者，禁止在國內市場銷售陳列。
