**Description:** This document delays until 20 March 2025, the effective date of the 20 December 2024, [final rule](#) (notified as [G/TBT/N/USA/2113/Add.1](#)) that adopted Federal Motor Vehicle Safety Standard (FMVSS) No. 305a to replace FMVSS No. 305, "Electric-powered vehicles: Electrolyte spillage and electrical shock protection." FMVSS No. 305a applies to light and heavy vehicles and includes performance requirements for the propulsion battery. The final rule also established a part entitled, "Documentation for Electric- powered Vehicles," that requires manufacturers to compile risk mitigation documentation and submit standardized emergency response information to assist first and second responders handling electric vehicles.

Description of content:</b> Proposed rule - The Oregon Department of Environmental Quality (DEQ) is proposing this rulemaking to adopt minor California Air Resources Board (CARB) amendments to the Advanced Clean Trucks rules to maintain identity with CARB rules and adopt a Heavy-Duty Low NOx Omnibus implementation delay of 1 year which will replace a <a href="#">temporary rule</a> adopted by the EQC on 21 November 2024. This action will provide additional compliance flexibilities for manufacturers to meet the requirements under the Advanced Clean Trucks rules, ensure Oregon maintains identity with California's rules and address practical HD Omnibus implementation challenges.  The ACT Rule requires manufacturers to produce and deliver a certain percentage of new zero-emission medium- and heavy-duty vehicles over the next 10 years. The Low NOx Omnibus Rules require conventionally fueled heavy-duty engine and vehicle manufacturers to meet tougher oxides of nitrogen and particulate matter emission standards.  <b>擬議規則</b> - 俄勒岡州環境質量部（DEQ）正在提議這項規則制定，以採納加州空氣資源委員會（CARB）對先進清潔卡車規則的輕微修正，以保持與 CARB 規則的一致性，並採納重型低氮氧化物（NOx）綜合實施延遲 1 年，這將取代 2024 年 11 月 21 日由 EQC 採用的臨時規則。此舉將為製造

商提供額外的合規靈活性，以滿足先進清潔卡車規則的要求，確保俄勒岡州與加州的規則保持一致，並解決實際的重型綜合實施挑戰。

先進清潔卡車規則要求製造商在未來 10 年內生產和交付一定比例的新型零排放中型和重型車輛。低氮氧化物綜合規則要求傳統燃料的重型發動機和車輛製造商達到更嚴格的氮氧化物和顆粒物排放標準。
