**Description:** The Environmental Protection Agency (EPA) is issuing significant new use rules ([SNURs](#)) under the Toxic Substances Control Act ([TSCA](#)) for certain chemical substances that were the subject of premanufacture notices ([PMNs](#)) and are also subject to an Order issued by EPA pursuant to TSCA. The SNURs require persons to notify EPA at least 90 days before commencing the manufacture (defined by statute to include import) or processing of any of these chemical substances for an activity that is designated as a significant new use in the SNUR. The required notification initiates EPA's evaluation of the conditions of that use for that chemical substance. In addition, the manufacture or processing for the significant new use may not commence until EPA has conducted a review of the required notification; made an appropriate determination regarding that notification; and taken such actions as required by that determination.

This rule is effective on 12 August 2025. For purposes of judicial review, this rule shall be promulgated at [1 p.m. Eastern Standard Time \(EST\)](#) on 27 June 2025.

美國環境保護署（EPA）依據《有毒物質管制法》（TSCA）對某些曾提交製造前通知（PMNs）且亦受美國環境保護署根據《有毒物質管制法》發佈命令所規範之化學物質，發布重大新用途規則（SNURs）。根據該重大新用途規則，任何人如欲開始對其中任何化學物質從事被指定為重大新用途之製造（依法律定義亦包括進口）或加工活動，必須至少於開始前九十日通知美國環境保護署。此項通知將啟動美國環境保護署對該化學物質使用條件之評估程序。此外，在美國環境保護署完成對該通知的審查、就該通知作出適當判定，並根據該判定採取必要行動之前，不得開始該重大新用途之製造或加工。

本規則自 2025 年 8 月 12 日生效。就司法審查而言，本規則將於 2025 年 6 月 27 日美國東部標準時間下午 1 時正式發布。

**Description:** The California Air Resources Board (CARB) staff invites participation in a public workshop to discuss the implementation of the 2022 Amendments to the Transport Refrigeration Unit (TRU) Airborne Toxic Control Measure (ATCM), the next TRU rulemaking, and an update to the emission inventory that will also serve as a draft baseline for the development of the next TRU Regulation to require TRUs to meet more stringent emission standards.

The purpose of this workshop is to present updates on the United States Environmental Protection Agency's (U.S. EPA) Authorization and implementation of the 2022 Amendments, status of the next TRU rulemaking, and discuss updates to the emissions inventory. The workshop will provide an early opportunity to provide feedback on the data and methods that will be used in the baseline emissions inventory for the next TRU rulemaking. During the workshop, staff will answer questions and solicit input from attendees.

**Description:** The Pipeline and Hazardous Materials Safety Administration (PHMSA), in coordination with the Federal Railroad Administration, is amending the Hazardous Materials Regulations in response to the recent decision of the United States Court of Appeals for the District of Columbia Circuit in *Sierra Club, et al. v. DOT, et al.*, No. 20-1317 (17 January 2025).

**Description:** The Environmental Protection Agency (EPA) is issuing significant new use rules ([SNURs](#)) under the Toxic Substances Control Act ([TSCA](#)) for certain chemical substances that were the subject of premanufacture notices ([PMNs](#)) and are also subject to an Order issued by EPA pursuant to TSCA. The SNURs require persons to notify EPA at least 90 days before commencing the manufacture (defined by statute to include import) or processing of any of these chemical substances for an activity that is designated as a significant new use in the SNUR. The required notification initiates EPA's evaluation of the conditions of that use for that chemical substance. In addition, the manufacture or processing for the significant new use may not commence until EPA has conducted a review of the required notification; made an appropriate determination regarding that notification; and taken such actions as required by that determination.

This rule is effective on 22 August 2025. For purposes of judicial review, this rule shall be promulgated at [1 p.m. \(EST\)](#) on 7 July 2025.
