Leather and leather products (Except 15.11 Tanning and dressing of leather ; dressing and dyeing of fur)" ; "10. Manufacture of coke and refined petroleum products (Except 19.2 Manufacture of refined petroleum products)" ; "23. Manufacturing not elsewhere classified (Except 32.11 Striking of coins ; 32.12 Manufacture of jewellery and related articles ; 32.99 Other manufacturing n.e.c.)".

4. The recognition scope for Global of Thailand excludes the manufacturing of computer, electronic and optical equipment.

5. The recognition scope for KSA of Korea does not apply to the CNS Mark Certification System.

6. The recognition scope 23 for MSCI of Thailand is limited to protective helmets (except sports headgear) and protective goggles, and does not include other items covered under Scope 23.
