(CNS 14408 is removed from the inspection standard) 標準檢驗局提案修正有關使用直流電的聲頻擴大器之檢驗標準僅為 CNS 13439(CNS 14408 自檢驗標準中刪除)</p> <p>3.The BSMI proposes to extend the inspection scope of monitors and monitors used in automatic data processing, regulating the inspection requirement for head-mounted monitors.
