5. Title, number of pages and language(s) of the notified document: Draft Amendment of Technical Specifications for Mobile Broadband Business Terminal Equipment (33 page(s), in English; 24 page(s), in Chinese)

Description of content: The amendment of "Regulations Governing the Operating Items and Scope, the Timetable for Deregulation and the Number of Operators to Be Allowed for Type I Telecommunication Enterprises" was published on 18 April 2017, which released 1800 MHz and 2100 MHz frequency bands for mobile broadband services. Also, the referenced standard CNS 15285 - "General requirements and test methods for chargers used by mobile terminals and other hand-held ICT devices" was revised on 14 July 2017. To be in line with such changes, the NCC proposes to revise the "Technical Specifications for Mobile Broadband Business Terminal Equipment".
