Description of content: Proposed rule In this document, the Federal Communications Commission (FCC or Commission) proposes and seeks comment on changes to the rules that govern the operations of three distinct bands of spectrum, modernizing rules to facilitate opportunities for Advanced Air Mobility (AAM) and Uncrewed Aerial Systems (UAS). First, the Notice of Proposed Rulemaking (NPRM) proposes and seeks comment on opening up the 450 MHz band to aeronautical command and control operations; allowing for a single, nationwide license in the band; and adopting flexible licensing, operating, and technical rules that will facilitate robust use of the band at a range of altitudes while minimizing interference to neighboring operations. It also proposes expanding radiolocation operations in the 24.45-24.65 GHz band for uncrewed aircraft system detection operations. Finally, the NPRM proposes to modernize the Commission's legacy power rules for Commercial Aviation Air-Ground Systems in the 849-851 and 894-896 MHz band, which is used for in-flight connectivity.

促進在各種高度範圍內對該頻段的強大使用,同時最大限度地減少對鄰近操作的干擾。它還提出擴展 24.45-24.65 GHz 頻段的無人航空系統檢測操作的無線電定位操作。最後,NPRM 提出現代化委員 會在 849-851 和 894-896 MHz 頻段的商業航空空地系統的傳統功率規則,該頻段用於飛行中的連 接。

**Description:** In this document, the Federal Communications Commission (Commission) revises the Wireless Emergency Alerts (WEA) rules to allow alert originators the option to send "silent alerts" that do not trigger WEA's common audio attention signal or vibration cadence. This action grants alert originators greater flexibility in tailoring how WEA messages are presented. Further, to make as clear as possible to the public that any device marketed as a "WEA-capable mobile device"

adheres to the full suite of WEA capabilities, the Commission also adopts its proposals to define a "WEA-capable mobile device," for the purpose of compliance with the Commission's WEA requirements.

The definitions of a WEA-capable mobile device and a mobile device for the purpose of WEA (section 10.10(j) through (m)), along with conforming edits (to the introductory text of section 10.500, section 10.500(i) through (j), the introductory text of section 10.520, and the introductory text of section 10.530), will become effective 15 September 2025. **Description:** On 16 November 2024, the <u>Environmental Quality Commission</u> adopted rules to establish the Climate Protection Program in Oregon, as OAR Chapter 340, Division 273.

On 13 March 2025, the Commission adopted temporary rule OAR-340-273-0400. The temporary rule amendment was needed to implement the correct and intended methodology for the one-time

distribution of additional 2025 compliance instruments. This temporary rule does not introduce any policy changes.

The Oregon Department of Environmental Quality (DEQ) proposed a temporary rule amendment to the recently adopted Climate Protection Program. The temporary rule amendment was needed to implement the correct and intended methodology for generating additional 2025 compliance instruments. This temporary rule does not introduce any policy changes.

The Climate Protection Program sets an enforceable declining cap on greenhouse gas emissions from fossil fuels used throughout Oregon, including diesel, gasoline, and natural gas. The program is designed to reduce these emissions by 50% by 2035 and 90% by 2050. In addition to significantly reducing climate pollution, the program:

- Supports reductions in other types of air pollution.
- Improves public health in Oregon communities, particularly environmental justice communities most impacted by pollution and climate change.
- Prioritizes equity by promoting benefits and alleviating burdens for these communities including communities of color, tribal communities, rural communities, and communities experiencing lower incomes.
- Provides regulated parties with compliance flexibility options to manage their costs.
- Supports a strong economy.

氣候保護計劃對俄勒岡州使用的化石燃料(包括柴油、汽油和天然氣)設置了可執行的逐步減少的溫室氣體排放上限。該計劃旨在到 2035 年減少這些排放量的 50%,到 2050 年減少 90%。除了顯著減少氣候污染外,該計劃 還:

- 支持減少其他類型的空氣污染。
- 改善俄勒岡州社區的公共健康·特別是受污染和氣候變化影響最大的環境正義社區。
- 通過促進利益和減輕這些社區的負擔來優先考慮公平,包括有色人種社區、部落社區、農村社區和低收入 社區。

The absence of harmonised requirements for certain categories of measuring instruments is leading to the emergence of diverging national legislation, which would result in higher costs for economic operators and consumers. Additionally, this could also cause delays in the rollout of technologies that are key for achieving the EU's objectives of ensuring a high level of environmental protection and consumer safety. Moreover, some essential requirements set down in the MID are no longer technology neutral (e.g. display requirements) which prevents the use of modern solutions and their associated benefits in terms of convenience and consumer protection. Title, number of pages and language(s) of the notified document: Draft Commission implementing regulation on the technical description of the categories of important and critical products with digital elements pursuant to Regulation (EU) 2024/2847 of the European Parliament and of the Council; (4 page(s), in English), (11 page(s), in English)
- 6. Description of content: This draft Commission implementing regulation is adopted pursuant to an obligation stemming from the main legal act (the Cyber Resilience Act). It specifies the technical description of the products listed in Annex III and IV and which are subject to more stringent conformity assessment procedures.

Specifically, as foreseen by Article 32 of the Cyber Resilience Act, important products with digital elements that fall under class I as set out in Annex III will either need to follow harmonised standards, common specifications, or European cybersecurity certification schemes, or otherwise undergo third-party conformity assessment.

Important products with digital elements that fall under class II as set out in Annex III and critical products with digital elements as set out in Annex IV will need to undergo third-party conformity assessment.

The main regulation therefore tackles on the one hand, the current low level of cybersecurity of many of products with digital elements placed on the EU internal market and on the other hand, the fact that manufacturers tend not to provide updates to address vulnerabilities throughout the lifecycle of those products. The rules propose to address these two aspects by introducing mandatory horizontal cybersecurity requirements for manufacturers and an obligation to provide up to date information and instructions to customers.

The rules place responsibility on manufacturers, who must ensure conformity with security requirements of products with digital elements that are made available on the EU internal market. As a result, the rules aim to prevent deceptive practices and enhance consumer protection. They will also support business users and consumers by enhancing the transparency of the security properties and by ensuring better protection of fundamental rights, such as the right to privacy and data protection. By preventing cybersecurity incidents stemming from unsecure products with digital elements, the regulation will enhance the protection of human health and safety.

The rules also aim to harmonise and streamline cybersecurity requirements for products with digital elements and avoid overlapping requirements stemming from different pieces of EU sectoral and national legislation. This would create greater legal certainty for operators and users across the Union, including non-EU operators aiming at entering the EU market.; Prevention of deceptive practices and consumer protection; Protection of human health or safety

A circular economy is a model system where production, consumption, and recycling are intertwined together to ensure that materials never become waste but rather are reused thus reducing the environmental impact of human activities. This law works towards a circular economy by setting post-consumer recycled content usage requirements for initiators of deposits (IOD) and spirits manufacturers in the plastic beverage container industry. The reporting requirements in this law mandate that IODs and spirits manufacturers annually submit a report to Maine DEP detailing the amount of post-consumer recycled (PCR) plastic and overall percentages of plastic usage in beverage containers sold, offered for sale, and distributed in the previous year. It also establishes a waiver process and fee structure within the program to aid the department in measuring and ensuring compliance. Maine is one of just a handful of states that have passed laws requiring the usage of post-consumer recycled content to support the long-term sustainability of Maine's municipal recycling programs and beverage container redemption programs.
	The DEP will hold a stakeholder meeting on the topic of post-consumer recycled content in plastic beverage containers on 23 April 2025 from <u>9:00 am to 12:00 pm Eastern Time</u> . As a reminder, the meeting provides an opportunity to share comments and allow for
