## MEMORANDUM OF UNDERSTANDING FOR ESTABLISHING THE COOPERATION BETWEEN ÖQS -BCIQ

### 1 Objective

### 2 Scope

The undersigned parties being independent non profit third party certification bodies (operating according to EN 45012) have agreed to cooperate in providing a full service in the field of Quality System assessment and certification based on EN 29001, EN 29002 or EN 29003 standards (ISO 9001, ISO 9002 or ISO 9003).

### 3 Application

Each signatory agrees, as appropriate, to:

- cooperate in QS assessment in the form of joint audits;
- Coordinate the work to be performed for the quality system certification of an organization having subsidiaries in Austria and Taiwan, ROC in order to help such an organization to obtain the appropriate QS certificate;
- issue ÖQS and BCIQ certificates simultaneously after performance of a joint audit;
- take actions to achieve mutual recognition of QS certificates in the future.

Each signatory also agrees to:

- contribute to the development of operating procedures and promotional material;
- present in an appropriate way the information on OQS and BCIQ;
- present the collaboration between ÖQS and BCIQ to the EQNET members;
- promote the benefits of this bilateral agreement.

Before the realisation of any of the above actions an agreement on details should be made.
